Priority of Access

One of the main reasons the Australian Government funds childcare is to meet the Child Care needs of Australian families. However the demand for Child Care sometimes exceeds supply in some locations. When this happens, it is important for services to allocate places to those families with the greatest need for childcare support.

The Australian Government has Priority of Access Guidelines for allocating places in these circumstances. These guidelines apply to centre-based Long Day Care, In Home Care, Family Day Care and Outside School Hours Care services. They set out the following three levels of priority, which Child Care services must follow when filling vacant places:

Within these main categories, priority should also be given to the following children:

- Children in Aboriginal and Torres Strait Islander families
- Children in families which include a person with a disability
- Children in families which include an individual whose adjusted taxable income does not exceed the lower income threshold... or whose partner is on income support
- Children in families with a non-English speaking background
- Children in socially isolated families
- Children of single parents.

Staffing Ratios

The Education and Care services National Regulations and National Law require that services maintain the required educator to child ratios at all times based on the ages and number of children being educated and cared for at the service.

The National Regulations allow a child to be considered over preschool age from the beginning of the calendar year in which they will attend school as long as they are enrolled/registered. This is to assist services that structure enrolments from the beginning of the school year, such as vacation care for school age children.

The educator to child ratio for children over preschool age is 1 educator to 15 children (on site).

The educator to child ratio for children over preschool age is 1 educator to 8 children (excursion).

The educator to child ratio for children over preschool age is 1 educator to 5 children (water excursion).
